

# OWLCON DEALER AGREEMENT FORM

## 1. Definition of Terms

- 1.1. The vendor known as \_\_\_\_\_ and all employees are hereafter referred to as “**Dealer.**”
- 1.2. Fast Warp is a Rice University student club. Officers of Fast Warp will hereafter be collectively referred to as “**Fast Warp Officers**” and any one of this group as “**Fast Warp Officer**”.
- 1.3. OwlCon is a gaming convention, organized and operated by Fast Warp, that occurs annually at Rice University (Houston, TX). The OwlCon gaming convention will hereafter be referred to as “**OwlCon.**”
- 1.4. The **Rice University Police Department** is the law enforcement organization with jurisdiction over **OwlCon**.

## 2. Agreement

- 2.1. **Dealer** agrees to meet all of the following conditions as a requirement for being a dealer at **OwlCon**:
  - 2.1.1. **Dealer** will not be in possession of any **contraband** at any time at **OwlCon** for any reason. This includes possession of **contraband** for purposes of selling, as personal property, or for any other reason. **Contraband**, for purposes of this agreement, includes the following items:
    - 2.1.1.1. Weapons (examples include: knives, swords, axes, firearms). The **Rice University Police Department** no longer grants exceptions to this university policy.
    - 2.1.1.2. Any Illegal Items (examples include: illegal drugs, **bootleg** recorded media)
    - 2.1.1.3. Any Adult Material (examples include: pornographic videos and/or printed material)
  - 2.1.2. **Dealer** will inform all employees that will be present at **OwlCon** of the details of this agreement prior to their participation at OwlCon.
  - 2.1.3 **Dealer** will make a reasonable effort to share resources with fellow Dealers, to include: unloading space, equipment dollies, and electrical outlets.
  - 2.1.4 **Dealer** will make an effort to avoid unduly obstructing the view of other Dealer booths. OwlCon reserves the right to limits displays or behavior that interferes with the ability of other Dealers to to conduct their business.
- 2.2. Failure to comply with any of the conditions outlined in Section 2.1 can result in any or all of the following actions:
  - 2.2.1. Expulsion of **Dealer** from **OwlCon** without any refund of dealer fees.
  - 2.2.2. Confiscation of **contraband**.
  - 2.2.4. Expulsion of employees of **Dealer**. Replacement employees of **Dealer** may be allowed at the **Fast Warp Officers**’ discretion.
